Horton, Inc.) to rezone 44.52 +/- acre tract of land (Parcel IDs: 09F210100880087, 09F170200751242, 09F170200750012, 09F170100744685, and 09F170100742382) on property zoned PUD (Planned Unit Development) to create a new PUD with an underlying residential of R-6, Single Family District generally located east of Vickers Road and approximately 150 feet from Highway 92 to construct 136 single family dwelling units. (Planning Commission & Staff Recommends Approval with Conditions) (This item was previously tabled for 30 days).
