This item was added to the consent agenda.

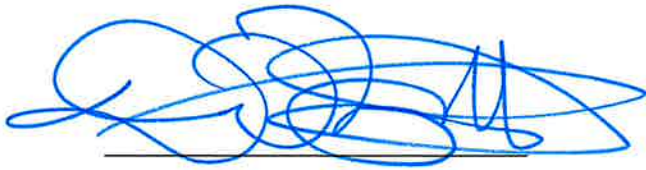
- B. Council to review the submittal of a request to approve the Regular Council Meeting Minutes dated October 22, 2024.

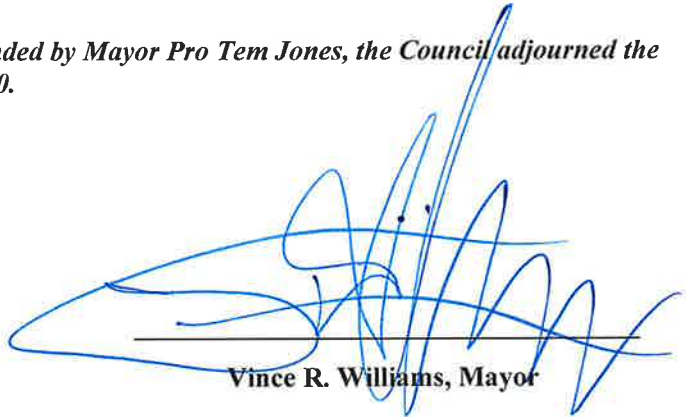
