A **Public Hearing** to review a city-initiated text amendment to amend Section 6-15 of Article VI of the Zoning Ordinance of Union City by revising language pertaining to industrial uses in the TCMU Town Center Mixed Use zoning district so that such uses are considered conditional uses and to create a new Section 5-43 of Article V of the Zoning Ordinance of Union City by establishing provisions clarifying that conditional uses are allowed by right in a zoning district, provided that the conditions for such uses are met, and clarifying that no additional permit is required. Planning and Zoning Commission recommends **approval**. Staff recommends **approval**.
